



# Weberville Community Model Forest



## Exciting future for the WCFA

It has been another exciting year for the Weberville Project under the management of the Weberville Community Forest Association. Since its inception in April 2008, the project has focused its efforts on developing community-based forest management on private land. This has included activities such as creating the community-run board, conducting forest inventories, tree planting opportunities and various other extension activities.

This past year was no exception as the WCFA held its AGM on May 20th and was able to reflect on its accomplishments. Some notable highlights are the more than 10 miles of cleared recreational trails, over 40,000 trees planted, 36 private land inventories, and the 14 woodlot management plans developed for private landowners.

As for Phase III of the project, which commenced on April 1st of this year, there are already a number of exciting accomplishments and a bright future is up ahead. In June, the WCFA was awarded the Grassroots Environmental Stewardship award by the Alberta Stewardship Network. In July, a number of area landowners had trees planted through an initiative of the Woodlot Association of Alberta. And in August, the WCFA was officially welcomed as the 15th member of the Canadian Model Forest Network! This prestigious membership will greatly assist the WCFA to expand and implement its vision as model for other forest-based communities.

Upcoming projects will see continued private land inventories, more tree planting opportunities, further recreational trail development, and greater educational opportunities. In addition, an application to Alberta Innovates which was initiated by FPInnovations, Daishowa-Marubeni International and the novaNAIT Boreal Research Institute, that if approved, will see the Weberville Community Model Forest play a central role. The focus of the application is to conduct feasibility studies in three potential areas of development; biomass energy, tree cropping, and pulp mill sludge applications as fertilizer. Should the application be approved the feasibility studies would start this fall.

# Plans for Phase III

## Woodlot Tour of the Peace Country

On Saturday, August 7th, the Woodlot Association of Alberta (WAA), in partnership with the Alberta Forest Extension Network (AFEX), held a Woodlot Tour of the Peace Country. Over 30 people from throughout Alberta joined the tour and were treated to a full day of educational and interesting woodlot sites. Stops included a tour of the Rafter 86 Studio birch syrup operation, a presentation by Juri about the Weberville Project, a visit to the Murdoch Lake Agro-forestry Demonstration site, the DMI tree improvement test site, and the NPARA trials, as well as a tour of the Peppler Tree Farm and the Peace Cherry Ranch.



## Woodlot Inventories

Patrick is back once again. He arrived by the end of July and is now preparing the woodlot management plans as well as the landscape level plan. Once the management plans are completed, he will be conducting inventories until he leaves the end of September. Patrick will also be joined by an assistant, also from Germany, and also coincidentally named Patrick (amicably referred to as Patrick #2) who arrives in Canada on August 25<sup>th</sup>. Patrick #2 will be assisting in conducting the woodlot inventories. Many landowners have already signed up to have the free woodlot inventory conducted. In addition, the remaining woodlot inventories from last year will be finalized. The priority is to complete all of the previous inventories and to conduct at least another six inventories this year.

Inventories which were completed last year will be distributed to those landowners shortly. Patrick will be contacting the landowners to set a meeting date to discuss the inventory and findings. He will also gather input for the management plan and collect some information from the landowners about goals and objectives. The data that has been collected so far gives a great overview over the area and helps creating the landscape level management plan. Tables and charts have been already created to explain the collected data more easily. Recommendations and an example of a community approach for a project will be included in the first volume of the landscape level plan.

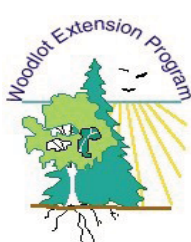
